Assurances

As a student at the Tita Yanar Early College High School through Sul Ross University, I understand that:

- I must meet the attendance requirements of Sul Ross State University, and it is my responsibility to contact my instructor and high school Dual Credit Facilitator about issues with my attendance, grades, or other matters. Attendance, midterm grades, and final grades will be shared with my high school and the university.
- I understand that I am subject to the university's policies regarding grades, academic standing, Student Code of Conduct, and Student Academic Rights and Responsibilities.
- I understand my high school Dual Credit Facilitator or assistant principal cannot withdraw me from a college course, I must initiate the process. Any

additions or changes to my courses must go through my high school Dual Credit Facilitator and assistant principal who will submit the required forms to the university. For withdrawals, I understand the EPLA Early College withdrawal form must be completed and turned into the high school Dual Credit Facilitator so that it can be sent to the college in order for me to be withdrawn from a course. Keeping track of the last day to withdraw with a W is my responsibility. If I do not withdraw with a W and Fail the class this will affect my academic standing and possible future financial aid status.

- The grades that I earn in my college courses while in the dual credit program, will be a part of my college transcript that will stay with me throughout my college career. I understand that these grades impact my future financial aid eligibility.
- If I am taking this course for dual credit, I understand that my high school GPA may be affected by my college grades, thus affecting my high school graduation rank and status.
- I have the ability to seek support for my college courses from a variety of academic and student support resources through the university, including free tutorial assistance.
- Parents/Guardians need a student's permission to access their college file. The Family Education Rights and Privacy Act (FERPA) is a federal law that describes how schools and colleges keep and/or distribute student information and records.
